Letter of Extension of Affiliation

Madam/Sir,

Under Section 9 of Himachal Pradesh Technical University Act, 2014 and pursuant to the recommendations of Board of Affiliation, provisional Affiliation/Extension of affiliation is hereby granted to **T.R. Abhilashi Memorial Institute of Engineering and Technology, Tanda, P.O. Balt (Ner-Chowk), Tehsil-Sadar, District Mandi (H.P)** for conduct of following courses for the academic session 2024-25:-

The affiliation is subject to fulfillment of the following deficiencies in the Institution/college pointed out by the Expert Committee in their report/ recommendations.

- *Institution is required to apply/initiate the process for NBA/NAAC accreditation. The accreditation is mandatory to grant the affiliation as per HPTU ordinance/norms.*
- *Institution is required to appoint qualified faculty as per AICTE norms.*
- *Faculty cadre ratio as per AICTE norms is required to be maintained.*
- *Idea lab/ Startup cell as per AICTE norms needs to be maintained and more activities must be planned.*
- *FDPs/Seminars/Webinars must be organized. More faculties must be allowed to attend FDPs/Seminars/Webinars.*
- *Institution is required to establish Red Ribbon Club and Scout & Guides units.*
- *Institution is required to ensure the registration/participation of all the students and faculty on SWAYAM portal/MOOC courses as per the Mandate of AICTE.*

The above mentioned approval is further subjected to following conditions failing which the process of disaffiliation may be initiated.

- a) No excess admissions shall be made by the Institution over and above the sanctioned intake approved by the AICTE/HPTU.
- b) The institution will not close or start new course(s) or alter intake capacity of seats without prior approval of the AICTE/ HPTU.

- c) Institution shall not charge tuition and other fees, other than as prescribed by the Govt. of Himachal Pradesh / HP Technical University. No capitation fee, Industrial training fee, creation of examination center, fine for attendance, etc. shall be charged from the students in any form.
- d) The institution shall comply strictly with the provisions made under the Anti-Ragging Regulation notified from time to time by the UGC/AICTE/PCI/HPTU/State Government for prevention and prohibition of ragging in Institution/College.
- e) The institute will follow the admission procedure, University Calendar, syllabus, examinations procedure and other norms/standards as laid down by the HPTU from time to time.
- f) As per provision applicable in Himachal Pradesh Technical University, Ordinance No.61, Chapter -IV, Clause 9 (ix-x) and Schedule-V, In case, any college or institution is not satisfied with the decision of the University regarding grant/extension of affiliation, an appeal can be made to the Standing Appeal Committee for reconsideration of the decision with necessary supporting documents.
- g) As per the roster received from the State Govt. of HP, the multiplication factor of 1.22 shall be followed to maintain the prescribed percentage of reservation for EWS. Thus, intake of seats for course with intake of 30, 40 and 60 would be increased to 37,49 and 73 respectively (i.e. existing intake x 1.22).

Submission of compliance report is required in respect of above deficiencies along with documentary evidence within a period of two months from the date of issuance of this letter so that fresh affiliation letter may be issued.
